**COPPER STICKER UPDATE**

Workgroup met again Dec. 1 at which time G&F presented another bill completely outside what the workgroup had suggested. None of the funding alternatives suggested by the workgroup were involved in the presented draft. It also was Demanding MVD carry the load by having to change their entire programming for registrations.

The issues presented:

- 1) There is no longer a "Copper Sticker" as we know it to be but there will be a continuing RV Plate as mandated by statute. The significant change is that if ATV's, dirt bikes or UTV's purchase a \$25.00 RV Plate and they have all the equipment required for full highway/street registration & licensing, they can ride on ALL roads.
- 2) Licensed, registered full sized vehicles can drive on all roads now. The loop is the UN-licensed/registered full sized vehicles must pay the \$25.00 but it's good for only off-highway.
- 3) Az State Parks will remain the

administrators but G&F will now receive 35% off the top of approx. 10 M where they are getting 30% off the top of 2.5 M now. Substantial increase.

**PROBLEM:**

- Representative Jerry Weiers has now drafted a bill which makes the G&F draft look like heaven!
- 1) Would require THREE separate vehicle plates; a) for highway; b) for OFF-Highway only; c) for both ???
  - 2) ALL dollars would go through G&F. Remember, G&F receive approx. \$800,000.00 now that they do no accounting for.
  - 3) Sportsman group receive 20% for environmental rehab
  - 4) MVD are again involved but they will have to "split" dollars.
  - 5) RV Plate is \$50.00 first time, \$20.00 each year thereafter.
  - 6) No race events allowed.
  - 7) Money is split evenly in 1/3rds, Law enforcement; education; grants.
  - 8) Will form another Advisory Group to be appointed by the governor.

Not sure where this will all end up but the last word, as of Dec. 27 is:

- 1) Representative Weiers office is drafting ANOTHER bill combining the two, Back to the table January 3.
- 2) G&F state they will not support Weiers bill.
- 3) G&F also state they will kill a bill

with just OHV laws if we push for this for this year and wait on the funding proposal until next year.  
4) We have been told by Senator Jake Flake he will NOT support a Copper Sticker funding source. When G&F were asked "how is this any different" they feel that he will support it due to the fact the ATV's and bikes can license for highway for \$25.00 in lieu of \$97.00.  
5) Representative Weiers stated LOUD and CLEARLY: "In no way can the words "Copper Sticker" be heard or anything presented will die.  
6) The AZ OHV Coalition has proposed a numbers and percentage change to the G&F bill but if this is denied and they continue as is it will be brought back to the AZOHVC members for decision as to kill any bill that is put forth at this time.

### Environmental Affairs

The Copper Sticker meetings held around the state in the last few months were very well attended by the red shirts. A committee of off highway enthusiasts and Game and Fish representatives is being formed to decide how to administer the funds and to set the rules and rates. As it stands now, no one is sure exactly where the areas are. Also, the different environmental groups want to be on the

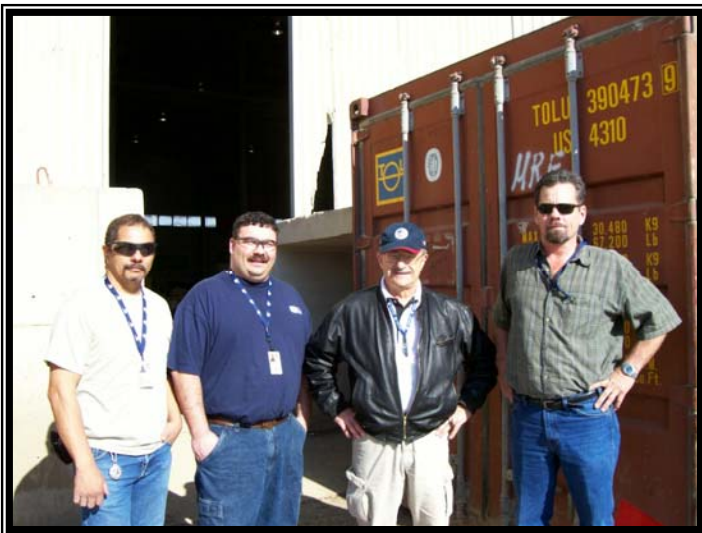
### Jack H. List

My job entails me to conduct site visits, meetings with the military, strategic partner, and many hours on the computer and phone coordinating people and

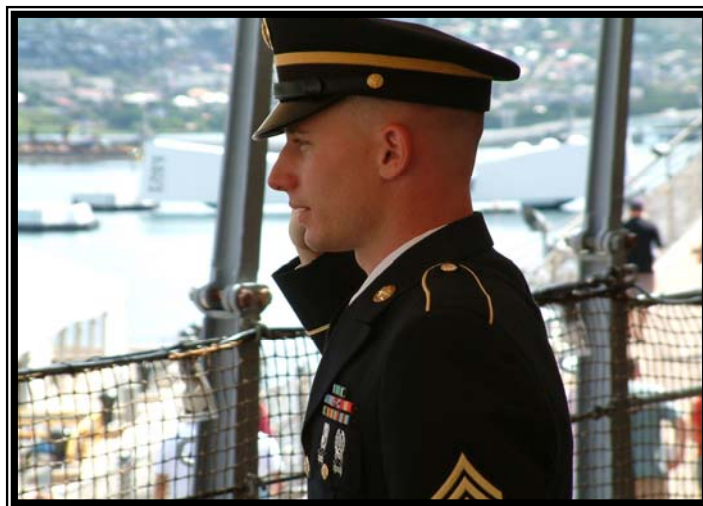
equipment. We work 7 days a week 12 hours a day in support of our outstanding American Soldiers who I am proud to serve with. HooAhh!

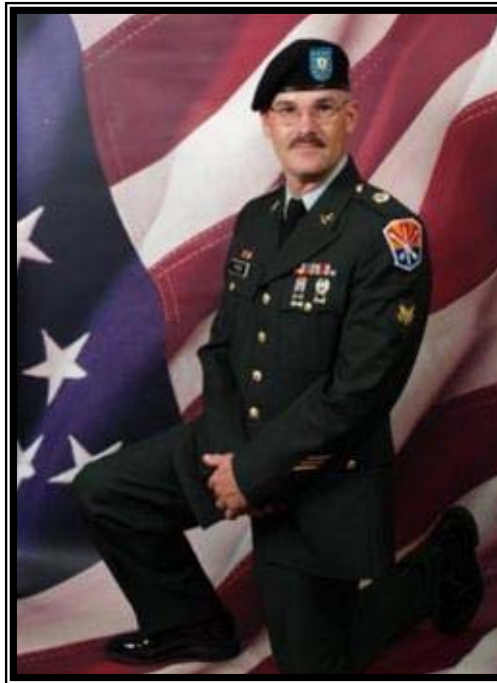

## **RECOMMENDED WILDERNESS AREAS**

From the Blue Ribbon Coalition Website: [www.sharetrails.org](http://www.sharetrails.org). This is happening in Montana, but it could happen here.

### **Situation:**

BRC, with help from Craig Osterman, Executive Director of the Treasure State Alliance (a new OHV umbrella group in Montana) has been tracking Forest Plan revisions for many months. Despite our efforts working within the planning process, the U.S. Forest Service is planning a de-facto Wilderness management regime on all "Recommended Wilderness Areas" (RWA).

Under normal circumstances, the "Recommended" Wilderness classification is just that: a recommendation. The decision of "whether Wilderness" is supposed to be

left to Congress and the American People.

Sadly, the Northern Region of the U.S. Forest Service seems to think they, not Congress, have the authority to manage these lands -- as Wilderness! New Forest Plans state that RWAs will now become closed to all motorized use, including winter snowmobile use.

### **Why you should care:**

The US Forest Service Region 1 (Northern Region) manages 25 million acres of public national forest and grasslands in Montana, North Dakota, northeast Washington, northern Idaho, and northwest South Dakota.

New Forest Plans, under the guidance of the Northern Region Forester, dictate that large areas will be classified as RWAs. Thousands of acres of prime

recreational lands will be included as RWAs in these new Plans. The new plans direct that RWAs will now become closed to winter snowmobile use and all other forms of motorized recreation.

No law or Forest Service policy requires the Forest Service to take such a drastic action. These closures would apparently be immediately imposed upon the completion of the new Forest Plan. No attempt will be made to postpone these closures until Congress passes legislation to legally designate these forest lands as Wilderness!

Only Congress has the authority to create designated Wilderness, but these RWAs are being treated as de-facto wilderness under the Region 1 Forester's direction as soon as they are created. This unlawful policy must be stopped immediately.

## ASA4WDC ROSTER IS ELECTRONIC



The ASA4WDC roster has gone electronic. The roster is now a web-based system.

## FOREST SERVICE DESIGNATION PROCESS



The following information was gathered from the Americans for Responsible Access, [www.ara-access.com](http://www.ara-access.com).

It is imperative that OHV enthusiasts participate in the route designation process in their local forest.

Each forest will have its own process and timetable for designating routes and there is no requirement that each forest submit proposed actions, meetings, etc. to any single clearinghouse. For this reason, we have created a Land Access Notification Database (LAND) as a means to submit information regarding the route designation process in individual forests.

This database allows you to submit meeting and process notifications that will, in turn, allow us to notify and engage key stakeholders in and around the affected forest. This process is designed to maximize awareness of local issues and to target appropriate responses, ensuring that the local forest is not negatively impacted by the route designation rule.

Please utilize the ARRA website as you become aware of any information pertaining to the implementation of the route designation rule.

### ARRA COMBINES FORCES WITH OTHER OHV INTERESTS IN AN

### EFFORT TO HELP ENSURE SUCCESSFUL IMPLEMENTATION OF OHV ROUTE DESIGNATION RULE

As ARRA has reported, the U.S. Forest Service (USFS) published its Travel Management; Designated Routes and Areas for Motor Vehicle Use rule on November 9, 2005.

The rule requires each National Forest or ranger district to designate those roads, trails, and areas that are open to motor vehicles. This will be a massive undertaking that will require individual forests and districts to undergo an extensive process of route identification, evaluation, designation and mapping.

Many forests have already started the process and others will begin soon. In an effort to help ensure that each forest hears and understands the needs of the OHV community ARRA has partnered with the:

Motorcycle Industry Council (MIC)  
Specialty Vehicle Institute of America (SVIA)  
National Off-Highway Vehicle Conservation Council (NOHVCC)  
American Motorcyclist Association (AMA)  
United Four-Wheel Drive Associations (UFWDA)  
BlueRibbon Coalition (BRC)  
to develop a land use database to collect and disseminate information regarding the USFS' Travel Management Rule.

ARRA members and members of the other associations will be able to input information about the rule, i.e. meeting times and locations, updates on status, concerns with the process etc. and ARRA and the other groups will be able to provide direction and assistance or help identify other off-highway enthusiasts in the area.

Representatives from each of the associations will review the collected data and work together to determine the most suitable course of action for each database submission. This collaborative approach will allow the allied associations to pool resources and memberships and provide for a comprehensive approach to dealing with route designation.

Please take this opportunity to review the [Land Access Notification Database \(LAND\)](#). If you have been active at a National Forest in your area please let us know by completing a database submission. If you are aware of upcoming meetings regarding OHV use or have a report about a recently completed meeting or hearing let us know.

Our groups are working together to do our best to ensure a successful implementation of the Travel Management rule but we cannot do this without your help.

Many Forests have outdated mailing lists

and will provide little additional notification about their processes or upcoming meetings. As such, it is crucial that all of our members become involved at the individual forest (and in some cases forest district) level.

Please stop by or call your local forest and ask to be placed on its mailing/email list for updates. Ask how they intend to implement the Travel Management Rule then enter what you learned into the Land Access Notification Database. With your involvement the OHV

community will have our voice heard at Forests all across the country, without your involvement there will be an almost guaranteed loss of access to National Forest land for OHV use.
